institution in relation to this procurement process prior to and during the bidding process except to provide clarification on the bid submitted where so required by the institution; and the bidder was not involved in the drafting of the specifications or terms of reference for this bid.

- 3.6 I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.

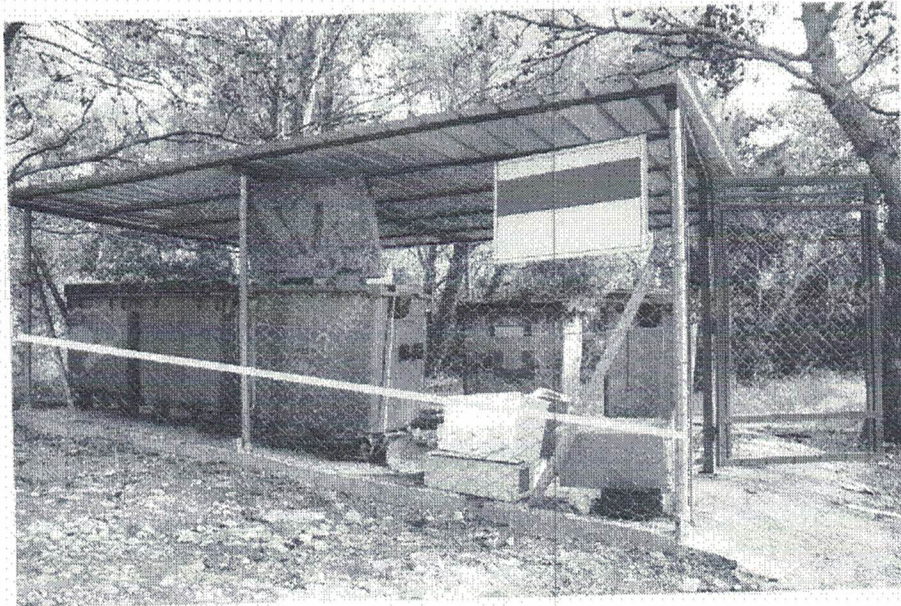

Specifications for Requisition

Construction of 18m² Refuse Cage

- Square Tube 4m x 95mm x 95mm
- 0.5mm x 18ft IBR Roofing sheet
- Crossing Lipped channels to support sheeting 4.2m
- Paint all posts and lipped channels with midnight blue enamel paint.
- Affix all of 95mm x 95mm upright posts with a 32mpa mortar concrete at 1.5m depth front and 1.75m depth at the back..
- 1.5m brick wall from the ground all round, then attach a 6320D EXPANDED METAL mesh up to the roofing
- A lockable 6320D EXPANDED METAL mesh wire gate (lxh=1.5m x 2.5m) as per the structure
