

Ministry are Universities, Universities of Technology and Sector Education and Training Authorities (SETAs). The focus of the DHET is set on addressing the skills shortages of our country by steadily increasing the number of students enrolled and trained in priority and critical skills areas.

Youth, who are categorised as NEETs (those not in Education, not in Employment and not in Training) is the niche target market that the DHET wishes to equip with the requisite skills base to overcome poverty and the dilemma of unemployment.

- of occupational programmes is housed under a single Quality Assurance Body
- ORBIT TVET College is ISO 9001:2008 compliant and is externally audited by SABS every six months
- Service delivery in the classroom and to clients in general is quality assured through the implementation of the Quality Management System (QMS) of the College
- Report 191 (N1-N3) programmes are quality assured by UMALUSI and Report 191 (N4-N6) programmes are quality assured by QCTO

NATIONAL CERTIFICATE (VOCATIONAL) NQF Level 2 - 4

WHAT IS THE NATIONAL CERTIFICATE (VOCATIONAL) [NC(V)] QUALIFICATION?

The NC(V) is the vocational programme at Level 2-4 of the National Qualifications Framework (NQF) and is offered by all public TVET Colleges countrywide. The qualification is intended to directly address the priority skills demands of the modern South African economy.

The NC(V) Qualification is designed to provide both theory and practice, thus granting students an opportunity to gain work experience during the period of study. Practical experience may be gained in either a simulated or real workshop environment.

WHICH NC(V) PROGRAMMES ARE OFFERED BY ORBIT COLLEGE?

CURRICULUM

Each NC(V) Qualification has a total of 7 SUBJECTS per NQF Level

Three of these subjects are called FUNDAMENTAL SUBJECTS, i.e. they are common for all learning fields and are COMPULSORY. The Fundamental Subjects are:

- Life Orientation
- · English 1st Additional Language

 Mathematics (Engineering & ICT fields) OR Mathematical Literacy (Business & Services fields)


Umalusi has officially communicated to the DHET its recognition of credit transfer between the NSC and the NC(V) in the following subjects:

- English Home Language or FAL (passed at 40% and above)
- Mathematics (passed at 30% and above)
- Mathematical Literacy (passed at 30% and above)
- Physical Science (passed at 50% and above)

It is important to note that this concession applies only to the National Senior Certificate (NSC) and NOT to its predecessor, the Senior Certificate (SC)

The other four subjects per NQF level are called VOCATIONAL SUBJECTS and these are aimed at preparing students for the world of work within the field of their choice. A specialisation vocational subject (Elective) forms part of the 4 vocational subjects in some qualifications, allowing a student to specialise in a specific subfield.



C1.11 NC(V) PASS REQUIREMENTS & HIGHER EDUCATION MOBILITY

WHAT ARE THE PASS REQUIREMENTS FOR NC(V) NQF LEVEL 2 - 4?

n order to progress to the next NQF Level students have to pass all SEVEN subjects. Once all 21 subjects have been passed successfully the NC(V) Qualification is obtained.

The pass rate requirement for the four vocational subjects is 50% per subject

The pass requirement for the fundamental subjects is as follows:

as follows.	
 Life Orientation 	40%
 English 1st Additional Language 	40%
 Mathematics/Mathematical Literac 	v 30%

Only one fundamental subject may be condoned for a maximum of 5%. No condonement for Vocational subjects. (T's & C's apply)

Should the student fail, he/she may be required to repeat the failed subject to obtain valid ICASS marks.

HOW ARE ASSESSMENTS AND EXAMINATIONS CONDUCTED FOR THE NC(V) QUALIFICATION?

he final pass mark is compiled by Internal Continuous Assessment, Integrated Summative Assessment and External Examinations marks.

Internal Assessment (ICASS) is conducted on a continuous basis while the External Examination is written in November every year. The practical assessment is conducted during the year in one sitting during September/October.

INTERNAL CONTINUOUS ASSESSMENT (ICASS)

he Internal Assessment comprises the following:

- 6 Assessment tasks consisting of 3 written tests, assignments and research/practical projects
- 1 Internal Examination

All of the above are contained in a Portfolio of Evidence (PoE) which counts as follows towards the final pass mark:

Fundamental Subjects : 25% of the final mark
 Vocational Subjects : 50% of the final mark

INTERNAL SUMMATIVE ASSESSMENT (ISAT)

he internal assessment comprises:

- One practical assessment for the three core subjects
- One practical assessment for the elective subject

EXTERNAL EXAMINATION

A national External Examination is set by the Directorate: Examinations & Assessment of the DHET. The same examination paper for a particular subject is written by all students on the same day. This sets national standards for assessments and achievement.

The External Examination counts as follows towards the final pass mark:

Fundamental Subjects

Integrated Continuous Assessment (ICASS) POE: 25% + National Examination: 75% = Pass Mark

Vocational Subjects

National Examination: Theory 70% + Integrated Summative Assessment Tasks (ISAT): Practical: 30% + (ICASS) POE: 50% = Pass Mark

CAN I JOIN A HIGHER EDUCATIONAL INSTITUTION (HEI) HAVING OBTAINED AN NC(V) QUALIFICATION?

Specific requirements must be met in accordance with the Government Gazette no. 32745 for programmes:

Guidelines for admission to undergraduate programmes:

The table below explains what you will need to achieve in order to meet the minimum statutory requirements for each type of qualification. It is important to note that the table below refers to the minimum requirements

Qualification	Minimum entry requirement
Higher Certificate	Must meet NC(V) level 4 statutory requirements 40% in either home language or first additional language but one must be LOTL 30% in either Maths or Maths Literacy 40% in Life Orientation 50% in the four other vocational subjects Submit a record of evidence for any subject failed
Diploma	 Must meet NC(V) level 4 statutory requirements 50% in three fundamental subjects including LOTL 60% in three compulsory vocational modules
Bachelor's Degree	Must meet NC(V) level 4 statutory requirements 60% in three fundamental subjects including LOTL 70% in four compulsory vocational modules

Additional requirements:

- Applicants will only be considered for similar gualifications
- Programme specific subject requirements must be met

C2 REPORT 191 (NATED) PROGRAMMES

earners who have completed a Grade 12 Certificate with a minimum of a Higher Certificate achievement can consider studying further at a TVET College for a National Diploma. The Report 191 (NATED) N4-N6 Programmes, also known as ALTERNATIVE POST-SCHOOL PROGRAMMES, are available in Engineering, Business, Performing Arts, Utility and Educational Studies. To complete the qualification, the student must complete the required 2000 working hours in the relevant field of study.

The Report 191 (NATED) N1-N3 Programmes in Engineering Studies are offered to those who wish to study towards an apprenticeship to become an artisan in the Civil, Mechanical Automotive and Electrical career fields. After completion of a minimum of an N2 (with four relevant subjects), successful candidates who are not yet employed, can apply to SETA and employers for possible selection into apprenticeship.



C3 ARTISAN DEVELOPMENT AT ORBIT TVET COLLEGE

ARTISAN DEVELOPMENT REMAINS A PRIORITY

Research conducted by the DHET projected that a significant number of artisans will be needed by 2020 due to a shortfall of artisans in the South African Labour Market. Addressing this projected shortfall of artisans has become a National priority.

The White Paper for Post-School Education and Training – Building an Expanded, Effective and Integrated Post-School System, as approved by Cabinet on 20 November 2013, has re-affirmed that establishing a good artisan system is an urgent priority for South Africa. In addition to this, the Medium Term Strategic Framework for 2014 – 2020, approved by Cabinet, has brought forward the National Development Plan target of 30 000 qualified artisans per annum by 2026 – 2030.

On 3 February 2014 the Deputy Minister, The Honourable Mr M Mduduzi Manana, of Higher Education and Training launched the Decade of the Artisan at Ekurhuleni East College, Kwa-Thema Campus. The aim of this campaign is to advocate apprenticeships to the young and to encourage employers to take on apprenticeships at an increased rate.

In order to implement the National Artisan Development Process in the TVET College system, a formal Memorandum of Understanding has been signed between the DHET and each of the fifty public TVET Colleges in the country to establish a Provincial Artisan Development Committee (PADC) in each province.

WHAT IS AN ARTISAN?

An artisan is a skilled, well-trained and tested individual who is qualified in a specific trade, e.g. Bricklayer, Electrician, Carpenter etc. An artisan crafts, maintains and repairs items that may be functional or decorative. Artisan trades extend beyond the scope of the Engineering field – gold smiths, hairdressers and beauticians are also regarded as artisans.

ARTISAN DEVELOPMENT ROUTES AT ORBIT TVET COLLEGE

p and until the occupational curricula and/RPL toolkits for Artisan Development have been developed the following routes are available at ORBIT TVET College to attain an artisanship:

- N2 Certificate with trade theory and 3 years relevant work experience
- Technical trade theory quality-assured by a SETA and a minimum of 3 years relevant work experience (NQF Level 3)
- Relevant National Certificate (Vocational) Level 3 Engineering qualification and 3 years relevant work experience
- Relevant National Certificate (Vocational) Level 4 Engineering qualification and 18 months relevant work experience

C3 ARTISAN DEVELOPMENT AT ORBIT TVET COLLEGE

QUALITY-ASSURANCE OF ARTISAN DEVELOPMENT

Artisan Development Programmes in South Africa are assessed and moderated by NAMB (the National Artisan Moderation Body as follows:

- Coordination of Artisan Development in SA
- Monitoring the performance of Accredited Trade Test Centres
- Moderation of Artisan Trade Tests
- · Recording Artisan Achievements
- Recommending certification of Artisans to the QCTO
- Development, maintenance and application of a national data bank of assessment instruments for assessment and moderation of Artisan Trade Tests

Quality assurance of Artisan Development Programmes is done by the Quality Council for Trade and Occupational Programmes (QCTO). This body ensures the availability, relevance and quality of Occupational Qualifications to meet the needs of industry. It also ensures that fit-for-purpose qualifications are registered to respond to the labour market needs.

In terms of the quality assurance of Report 191 NATED Programmes a transitional measure is currently in place that allows UMALUSI to quality-assure N1-N3 Report 191 Programmes and QCTO to quality-assure the N4-N6 Report 191 Programmes.



C4 OCCUPATIONAL LEARNING PROGRAMMES

WHAT ARE OCCUPATIONAL LEARNING PROGRAMMES?

Occupational Learning Programmes include Apprenticeships, Learnerships and Skills Programmes. The focus of these programmes is geared towards preparing students for a specific skills within a specific working environment related to a specific trade.

Occupational Learning Programmes are offered at the ORBIT TVET College as either FULL QUALIFICATIONS or as ACCREDITED SKILLS PROGRAMMES.

LEARNERSHIPS that are offered by the College combines theory at the College or Training Centre with relevant practice on-the-job. Occupational programmes are based on legally binding agreements between an employer, a student and a training provider. It is designed to ensure the quality of the training and to protect the interests of each individual party.

In order to become qualified, students must be assessed against unit standards registered with SAQA

SKILLS PROGRAMMES are unit-standard-based programmes that are demand-driven as determined by community needs. Such skills programmes offered by ORBIT TVET College are units standards extracted from formal full qualifications registered with SAQA for which the College obtained programme approval from the relevant SETA or Accredited Body.

A. DHET TVET COLLEGE BURSARIES FOR NC(V) AND REPORT 191

B ursaries will be awarded according to the 2017 DHETTVET College Bursary Guidelines

1. Who is eligible to apply for the DHET TVET College Bursary Scheme?

- Only South African Citizens qualify for this bursary scheme
- Applicants must be registered on the NC(V) or Report 191 programme at any of the (50) public TVET Colleges in South Africa
- Financially needy students with academic potential (a Means Test is administered to determine whether or not a student meets this criterion)
- Students with evidence of good academic performance
- Bursary Application forms can be completed by prospective qualifying students during the registration period

2. Application period to apply for the Bursary Scheme

Details regarding bursary application periods and availability of application forms can be obtained from Student Support Officials at the respective campuses

NO LATE SUBMISSIONS WILL BE ACCEPTED AFTER THE DHET APPROVED CLOSING DATE

3. Who qualifies for the DHET TVET College Bursary Scheme?

- The financial need of the student must be assessed using the NSFAS Means Test tool of each academic year when awarding bursaries to students
- Students MUST provide details on the employment status of their parents or guardian as these
 impacts on the eligibility for bursaries. In this regard, students must submit a death certificate if
 one/both parent(s) is/are deceased or an affidavit if they do not know their whereabouts
- An application that does not have particulars of both parents is incomplete and will NOT be accepted
- The academic merit of a student is assessed using an academic record or statement of results when awarding bursaries to students. To this end, students must be given priority in terms of their academic ratings
- Both the criteria for financial need and the academic merit must be applied. Students are
 categorised and prioritised in terms of their eligibility weightings. Students who have the greatest
 financial need (EFC rating A) and the highest academic rating (academic rating 1) must be in the top
 category and they must be given first priority accordingly
- Bursaries are awarded to the most deserving students on the basis of their highest degree of financial need and best academic performance

FINANCIAL ASSISTANCE/BURSARIES

- All NC(V) and Report 191 bursary recipients who FAIL to progress to the next level of their studies will
 NOT be awarded a bursary to repeat a level that they failed
- The bursaries should be awarded against an approved and signed agreement between NSFAS and the student this agreement is referred to as the Schedule of Particulars (SoP). It is important to note that only the students who have been awarded bursaries are required to sign the SoP
- Colleges must first and foremost prioritise the awarding of class fees to qualifying students.
 Colleges may consider the applications for travel and accommodation allowances subject to the availability of funds
- For new NC(V) Level 2 and Report 191 (N1 and N4) students, academic criteria must be applied using
 the school report, National Senior Certificate, N3 statement of results and the selection and
 placement tool results
- The College Financial Aid Committee must review documented evidence of satisfactory academic performance in awarding bursaries to students enrolling in Level 2 and N1 and N4 programmes
- Colleges are required to verify authenticity of schools and/or school reports that appear suspicious (i.e. without a school logo, address, Headmaster signature, etc.). To this end, colleges must contact the Provincial Education Department where the public or independent school is located
- Applicants who were awarded bursaries for NC(V) Level 2 and 3 in the previous year, and who have
 performed well academically in the previous academic year, and are therefore progressing to the
 next level, should be prioritised for bursaries for NC(V) Level 3 and Level 4 in the current year taking
 into account the college policy on student progression and the availability of funds
- On application, Report 191 programme students apply for all semester or trimester courses in the
 calendar year of study. Applicants who were awarded bursaries for Report 191 N1 to N5 in the
 previous semester/trimester, and, who have performed well academically in the previous
 semester/trimester, and are therefore progressing to the next N level, should be prioritised for
 bursaries for Report 191 N2 to N6 in the current semester/trimester taking into account the
 availability of funds
- The granting of a bursary in the current academic year (for students who were granted bursaries in the previous academic year) is subject to the student's financial situation not having improved. The student will have to provide evidence thereof (all income-related supporting documents) and complete all required forms

FINANCIAL ASSISTANCE/BURSARIES

- Students may be awarded bursaries up to a maximum of four years for the NC(V) programme.
 Bursary should be awarded only in the fourth year of study (after Level 4) to allow students to complete any outstanding subjects. This provision is only applicable to continuous study.
- No bursaries should be awarded in the fifth year of study
- Report 191 students may also be awarded bursaries if they have successfully completed N3 and N6
 and have outstanding subjects for full certification. This provision is made for a period of six months
 and it is applicable to continuous study which will be paid at pro-rata, i.e. proportional to 6 months
- With effect from 2013 bursary recipients who switch from one programme to another (i.e. from NC(V) to Report 191 programme N1 to N3 or (vice-versa) or change programmes within an NC(V) or Report 191 programme during the course of their studies are not eligible for financial assistance. Furthermore, bursary recipients who complete NC(V) Level 4 are not eligible for financial assistance should they want to enrol for another NC(V) programme or Report 191 programme N1 N3; similarly bursary recipients who complete Report 191 N4 N6 are not eligible for financial assistance should they want to enrol for another Report 191 N4 N6 or an NC(V) programme. However, bursary recipients who complete NC(V) Level 4 are eligible for financial assistance should they want to enrol for Report 191 N4 N6
- DHET Bursary (NSFAS) regulations state that no funds will be made if there is a balance in the student's account after his/her account has been settled
- No student will receive cash payment or refund from NSFAS/the college at the end of the year in respect of a bursary award granted to the student for the payment of fees or other expenses
- Re-allocation of unutilised bursary funds of students who drop out from the college during the
 course of their studies has audit implications, and such, the college must not consider that course of
 action. Colleges must return unutilised funds to the NSFAS for redistribution
- A physical verification of student financial status will be done

- The College must be satisfied that the student meets the criteria for academic capability using evidence of good academic performance
- The financial need of the student will be assessed by the Financial Aid Committee
- The bursaries shall be awarded against an approved application procedure
- Students will be duly informed on the status of the application after submitting all required information and documentation
- For new NC(V) Level 2 foreign students, academic criteria must be applied using the previous school report and the selection and placement tool results
- NC(V) Level 2, Level 3 and Level 4 foreign students who were awarded bursaries in the previous year
 and were unable to progress to NC(V) Level 3 and Level 4 respectively, cannot be awarded bursaries
 to repeat NC(V) Level 2, or Level 3
